## **Question #1**

However, what you really want is someone who is familiar with helping people like you and who has handled cases like yours. Personal injury cases can be complex, and the kinds of cases vary. Cases involving car accidents, for example, often require the expertise of medical and accident reconstruction professionals, so our firm has established a network of these experts to assist us during this type of case.

Ask a prospective attorney about their experience handling cases like yours. Ask for some examples of cases similar to yours that they have handled successfully. If they can't show you that they have experience handling these types of cases successfully, it's time to move on.

## **Question #2**

Is timely service delivered...and how is it delivered?  
How long can I expect to wait?

When dealing with your personal injury needs, the last thing you want is to be treated like a number. You want specialized, personal care...and you want it fast! You want someone who cares about you and your family. And, more than anything, you want a firm with the expertise to get the job done right.

With many "big box" firms (and even some small ones), it can take weeks to get an appointment. Most firms will promise timely service, but many don't deliver. Be sure to ask them exactly what you can expect. Ask how long the service will last. Ask them how long until you can expect to be seen and how long it will take for action on your case.

If you miss this question, it could be months before you realize you hired the wrong attorney.

### **Question #3**

Are you a member of the any local, state, or federal bar associations?

These associations are a critical aspect of professional growth, giving attorneys the latest news about legal issues and providing a collaborative environment for their members to succeed in the field of personal injury law.

If an attorney says they work in personal injury law, but they are not listed with these associations, there is a reason why. And that reason spells trouble for you and your case if you choose to work with them.

### **Question #4**

Is your practice focused on personal injury?

Be sure to find an attorney who: works with personal injury cases on a regular basis, is highly qualified, and (this is important) is dedicated in their personal injury work. Ask a prospective attorney how often

they handle personal injury cases and how much of their practice is dedicated to personal injury law.

A lot of attorneys handle a wide variety of cases. That's fine...but when it comes to your personal injury claim, doesn't it make sense to have someone on board who focuses on personal injury law?



## **Question #5**

Who will I be interacting with at your firm?

This last question could be the most important one you ask. Many law firms will shove you off to work with a clerk for weeks on end, and you may only get one meeting (if that) from the actual attorney.

The fact is, you want to find a firm where the attorney has set aside time to get to know you and to work with you personally, 1-on-1. While every firm will have clerks and assistants doing work on your case, you still want to get face-to-face, real access to your attorney. There is nothing like it.
