Will Your Estate Planning Documents Be Accessible When Needed?

Estate planning documents can help you protect yourself and your family and spell out your last wishes—but only if they are found. If your documents are gathering dust in a long-forgotten drawer, or worse, hidden away in a safe to which your family members don't know the combination, they won't serve their purpose when needed.

For example, if you are incapacitated, your family will need to access your power of attorney and your advance directive (also known as a living will). You won't be able to tell your family where your documents are and how to access them, which means that your family must have this information ahead of time.

Unfortunately, it isn't uncommon for people to have advance directives and other estate planning documents that their family doesn't know about.

Store the Documents Properly

You would be surprised how often people misplace documents from the estate plan or don't store them all together. If you want to keep your original estate planning documents at home, storing them in a fire and waterproof safe is recommended.

Some people store their documents in a safe deposit box at a bank, however, these can be difficult to access. Even jointly held boxes may be inaccessible without a court order if the bank discovers that one of the box renters has died.

It is essential to let your family and personal representative know where to find these estate planning documents in case something were to happen. You can also always provide copies of your documents to your trusted attorney and family members. Doing this ahead of time will help them execute your wishes when the time comes.

The number one mistake made by most people who have been responsible enough to have an estate plan prepared, is to believe once it is done they never have to think about it again.

There are many changes which occur within families and family businesses. Family members may die, children are born, divorces happen, assets and property are sold or acquired. It is necessary to periodically review your estate plan in order to ensure the changes in your life are properly reflected.

Whenever you need to make changes to your will or trust, you should get rid of the older copies of your documents and replace them with the new ones. This will ensure that there is no legal confusion and that your loved ones are working with the most recent documents.

If your current estate planning documents aren't found, it will be as though you didn't create them at all, leaving you at risk of not having your wishes honored.


Mac is also AV-rated by Martindale-Hubbell and this is the 4th year in a row he's been named for inclusion in the Best Lawyers in America®.

Chicken & Stuffing Casserole

1 box Stove Top Stuffing (chicken flavored)
1-2 pounds skinless chicken breast- diced
1 can cream of chicken soup
1/3 cup Sour Cream
16 oz bag of mixed vegetables
4 garlic cloves- minced
1/4 cup green onions
Salt and pepper to taste

DIRECTIONS:

- Spray 9x13 baking dish and preheat oven to 400 degrees.
- Sauté vegetables and garlic in butter/oil until soft.
- Combine all ingredients in a bowl. Add the sautéed vegetables and green onions.
- Pour into the baking dish.
- Prepare the stuffing as directed on box but replace water with chicken broth. Spread stuffing evenly over the chicken mixture.
- Place baking dish in oven and bake for 30 minutes or until the chicken is cooked through. Enjoy!

Chocolate Coca-Cola Cake

1 box of Super Moist Devil Food mix

1 box 3.9oz Jell-o Chocolate Pudding

1 1/4 cup of Cola Coca

½ cup vegetable oil

3 eggs

1 cup pecans (optional)

DIRECTIONS:

- Spray 9x13 baking dish and preheat oven to 350 degrees.
- Stir with a whisk all ingredients in a large bowl until blended.
- Pour mixture into the baking dish.
- Bake for 35 to 40 minutes.

CAKE ICING

1 stick of butter (melted)

1 tsp. vanilla extract

3 tsp. heavy whipping cream

2 cups of powdered sugar

1/4 cup cocoa powder

DIRECTIONS:

- Cook ingredients on low heat until creamy and well blended.
- Remove from heat and add pecans (optional).
- Pour icing over cake and allow to cool. YUM!
